Abstrak

Tesis ini membahas standar pengamanan yang dilaksanakan oleh Detasemen Pengamanan Objek Vital, Polres Metro Pelabuhan Tanjung Priok. Perhatian utama tesis ini adalah kegiatan kepolisian yang dilakukan oleh anggota Detasemen Penggunaan Objek Vital Polres Metro Pelabuhan Tanjung Priok dalam mengimplementasikan standar pengamanan guna mengamankan Pelabuhan Tanjung Priok sesuai dengan Skep Kapolri No. 738 I X I 2005 tentang Sistem Pengamanan Objek Vital. Penelitian ini menggunakan analisis kualitatif dengan metode etnografi dan teknik pengumpulan data pengamatan dan wawancara bebas.

Den Pam Obvit merupakan bagian dari Polres Metro Pelabuhan Tanjung Priok yang diberikan tugas mengamankan Pelabuhan Tanjung Priok. Kegiatan pengamanan dilaksanakan secara melekat di 7 buah industri dengan kegiatan dan kebijakan pengamanan yang berbeda. Sebagian besar pengamanan dilaksanakan dalam bentuk pengaturan, penjagaan, patroli dan program community policing serta pelaksanaan audit pengamanan.

Penelitian menunjukkan bahwa Den Pam Obvit belum mengimplementasikan Skep Kapolri No. 738 I X I 2005 tentang Sistem

.....The thesis analyses the implementation of safety standard conducted by Detasemen Pengamanan Objek Vital Tanjung Priok Harbour Police Resort. The main attention of this thesis is policing activity conducted by members of Den Pam Obvit Tanjung Priok Harbour Police Resort in implementing the safety standard to maintain the safety of Tanjung Priok Harbour, based on Skep Kapolri No. 738 I X I 2005 about Safety of Vital Objects. The research uses qualitative approach with ethnographic method by collecting data through observation and interview.

Den Pam Obvit is a part of Tanjung Priok Harbour Police Resort, with main duty to maintain the safety of Tanjung Priok Harbour. Den Pam Obvit is responsible to take care the safety of seven industries, each has different condition and safety policy. Den Pam Obvit generally maintains safety by doing "turjawalf", community policing program and implementing safety audit.

The research shows that the Den Pam Obvit has not implemented the Skep Kapolri No. 738 I X I 2005 on Safety of Vital Objects at the optimal level. For that reason, a number of cases on safety problems were found in
