Abstrak

Praktek Kerja Profesi Apoteker di Direktorat Bina Pelayanan Kefarmasian Direktorat Jenderal Bina Kefarmasian dan Alat Kesehatan Kementerian Kesehatan Republik Indonesia bertujuan memahami struktur organisasi, tugas, dan fungsi Direktorat Jenderal Bina Kefarmasian dan Alat Kesehatan, Direktorat Bina Pelayanan Kefarmasian, dan memahami peran apoteker dalam Direktorat Bina Pelayanan Kefarmasian. Kegiatan ini dilakukan di Direktorat Bina Pelayanan Kefarmasian. Direktorat ini mempunyai tugas melaksanakan penyiapan perumusan dan pelaksanaan kebijakan, dan penyusunan norma, standar, prosedur, dan kriteria serta pemberian bimbingan teknis dan evaluasi di bidang pelayanan kefarmasian.

Berdasarkan Peraturan Menteri Kesehatan Republik Indonesia No. 1144/MENKES/PER/VII/2010 tentang Organisasi dan Tata Kerja Kementerian Kesehatan, Direktorat Bina Pelayanan Kefarmasian yang berada di bawah naungan Ditjen Bina farmasi dan Alkes terdiri dari Subdirektorat Standardisasi, Subdirektorat Farmasi Komunitas, Subdirektorat Farmasi Klinik, dan Subdirektorat Penggunaan Obat Rasional.

Tugas khusus yang diberikan berjudul Mekanisme Pendaftaran Obat Dalam Pharmaceutical Benefit Scheme List. Tugas khusus ini bertujuan mengkaji pihak-pihak yang terlibat, tahapan pendaftaran obat, metode penetapan harga dalam Pharmaceutical Benefit Scheme list, dan mengkaji apakah Pharmaceutical Benefit Scheme sebagai salah satu sistem jaminan kesehatan di Australia layak diterapkan di Indonesia.
