Abstrak

Apotek merupakan sarana kesehatan yang berperan dalam upaya-upaya kesehatan, terutama untuk penyerahan obat dan perbekalan farmasi beserta informasinya kepada masyarakat. Berdasarkan Peraturan Pemerintah No.51 tahun 2009 tentang Tenaga Kefarmasian, apotek adalah sarana pelayanan kefarmasian tempat dilakukan praktek kefarmasian oleh Apoteker. Apotek sebagai sarana yang bergerak di bidang jasa pelayanan harus mampu memberikan pelayanan kefarmasian secara tepat dan bermutu. Seiring dengan meningkatnya tuntutan terhadap perbaikan pelayanan kefarmasian, termasuk di apotek, calon-calon apoteker diharapkan dapat menjadi pemberi pelayanan kefarmasian yang baik, serta pembaharu dalam dunia kefarmasian yang terus berkembang. Praktek Kerja Profesi Apoteker di Apotek Atrika dilakukan pada 23 september - 1 Novembaer 2014 guna memberikan pemahaman peran, fungsi dan tanggung jawab seorang Apoteker dalam pekerjaan kefarmasian di apotek. Dan calon apoteker mampu memahami dan melaksanakan kegiatan pelayanan kefarmasian di apotek, baik secara teknis kefarmasian maupun non teknis kefarmasian.
