### Abstrak

Les Romanesques merupakan trilogi karya Alain Robbe-Grillet, sineas dan sastrawan Nouveau Roman. Trilogi Les Romanesques terdiri dari Le miroir qui revient (1984), Angélique ou l'enchantement (1987), dan Les derniers jours de Corinthe (1994). Disertasi ini berusaha mengungkap cara penulis menggunakan teknik naratif dan naratologi serta intertekstualitas untuk mengacaukan genre teks.
