Abstrak

Suku Dinas Kesehatan merupakan lembaga pemerintahan yang bertanggung jawab dalam melaksanakan pelayanan perizinan, perencanaan, Pengadaan, pengendalian, dan penilaian efektivitas pelayanan kesehatan di wilayah kota administrasi dan kabupaten. Untuk mengetahui peran apoteker di Pemerintahan serta kendala dalam menjalankan pekerjaan kefarmasian di Suku Dinas Kesehatan, maka Program Profesi Apoteker Universitas Indonesia bekerja sama dengan Suku Dinas Kesehatan Jakarta Utara menyelenggarakan Praktek Kerja Profesi Apoteker periode 17 Juni-28 Juni 2013. Berdasarkan pengamatan selama praktek kerja di Pemerintahan, apoteker memiliki peran dalam pelaksanaan tugas dan fungsi Suku Dinas Kesehatan, yakni pada proses perizinan, pembinaan, pengawasan, dan pengendalian sarana serta tenaga kefarmasian. Kendala yang dihadapi dalam menjalankan pekerjaan kefarmasian yaitu pengadaan obat harus dioptimalkan dengan menerapkan sistem pengadaan elektronik sehingga dapat menghemat anggaran biaya puskesmas. Sedangkan dibidang pelayanan kefarmasian diseluruh puskesmas kecamatan di jakarta utara perlu ditingkatkan dengan penambahan jumlah apoteker. Pelaksanaan pengadaan obat secara e-purchasing sistem e-catalog di puskesmas kecamatan Kelapa Gading Jakarta Utara merupakan tugas khusus yang diberikan pada Praktek Kerja Profesi Apoteker ini.

Sub Health Department is the government agency responsible for implementing licensing services, planning, procurement, control, and assessment of the effectiveness of health services in municipalities and counties. Therefore, The Professional of Apothecary Program University of Indonesia in collaboration with sub health department administrative city Jakarta held a Professional Field Work of Apothecary, period of June17nd-June28st, 2013. Based on an observation, pharmacists have a role in the performance of duties and functions of the sub health department, which is in the process of licensing, training, supervision, and control facilities and personnel pharmacy. Problems in performing the work of pharmacy that drug procurement should be optimized by implementing an electronic procurement system so that it can save the cost of health center budgets. While the field of pharmacy services throughout the district health center in northern Jakarta needs to be improved with the addition of a pharmacist. The implementation procurement drug of e-purchasing with e-catalog systems in district health centers at Kelapa Gading, North Jakarta is special assignment report which given in this Professional Field Work of Apothecary.
