**Abstrak**

Kementerian Kesehatan Republik Indonesia (Kemenkes RI) merupakan badan pelaksana pemerintah di bidang kesehatan, dipimpin oleh Menteri Kesehatan yang bertanggung jawab langsung kepada Presiden. Praktek Kerja Profesi Apoteker (PKPA Dirjen Binfar Alkes bertujuan agar calon apoteker dapat mengetahui dan memahami peran, tugas, dan fungsi dari Kementerian Kesehatan, khususnya Direktorat Jenderal Bina Kefarmasian dan Alat Kesehatan. Selain itu, diharapkan dapat mengetahui, mempelajari, dan memahami kebijakan, penyusunan standar, norma, pedoman, kriteria, prosedur, dan bimbingan teknis serta evaluasi di Direktorat Bina Pelayanan Kefarmasian.
