### Abstrak

[Tesis ini membahas kepastian hukum atas batasan nilai gratifikasi sebagaimana diatur dalam Pasal 12B ayat (1) huruf b Undang-Undang Nomor 20 Tahun 2001 tentang Tindak Pidana Korupsi perihal nilai gratifikasi dibawah Rp 10.000.000,- (sepuluh juta rupiah), serta mengenai pelaksanaan lelang atas barang gratifikasi. Penelitian ini adalah penelitian hukum yuridis normatif yang bersifat ekplanatoris. Hasil penelitian menunjukkan bahwa terdapat banyak pengaturan mengenai nilai standar gratifikasi yang berbeda-beda. Muncul juga penafsiran gratifikasi yang tidak sesuai dengan UU Tindak Pidana Korupsi. Sehingga penulis menyarankan agar dilakukan unifikasi hukum nasional atas Pasal 12B ayat (1) huruf b UU Tindak Pidana Korupsi melalui peraturan pemerintah.
