### Abstrak

[Tesis ini membahas kegiatan perdagangan orang-orang Jepang di Hindia Belanda (Indonesia) pada kurun waktu 1920 sampai dengan 1940 karena pada kurun waktu tersebut, pasokan impor kebutuhan barang dari wilayah Eropa ke Hindia Belanda (Indonesia) terganggu karena terjadinya resesi ekonomi yang begitu berat. Pada kurun waktu tersebut Jepang berusaha untuk mengisi kebutuhan barang impor di wilayah Hindia Belanda dengan harga barang yang murah. Bagaimana peningkatan perdagangan Jepang di Hindia Belanda pada tahun 1920-1940 akan di bahas di dalam tesis ini melalui analisis dari media masa Jepang yang terbit di Hindia Belanda dalam kurun waktu 1920 sampai dengan 1940 maupun dari arsip-arsip mengenai kegiatan perdagangan Jepang di Hindia Belanda dalam kurun waktu antara tahun 1920 sampai dengan 1940.
