Perbedaan ideologi, budaya, agama, serta sikap eksklusif, menjadi penyebab tidak berjalannya dengan baik proses integrasi kelompok imigran Muslim dalam berintegrasi dengan masyarakat Belanda. Kondisi ini semakin diperburuk dengan melemahnya pandangan masyarakat Belanda terhadap nilai-nilai multikulturalis, terutama pasca tragedi World Trade Center tahun 2001.
