Abstrak

[Penelitian ini dilakukan untuk mereview regulasi tentang persyaratan luas minimal setiap kavling/unit perumahan di Kota Depok. Penelitian ini menggunakan metode Regulatory Impact Assesment (RIA) dengan menggunakan AHP untuk CBA dalam kuesioner untuk menganalisis dampak kebijakan tersebut pada saat diimplementasikan. Hasil penelitian ini menunjukkan bahwa alternatif kebijakan yang paling tepat dalam mengatasi permasalahan adalah dengan meniadakan ketentuan syarat luas minimal lahan setiap/kavling perumahan di

Kota Depok. Sehingga disarankan Pemerintah Kota Depok untuk mencabut ketentuan yang mengatur persyaratan luas minimal lahan setiap kavling/unit perumahan 120 (seratus dua puluh) meter persegi di dalam Peraturan Daerah Nomor 13 Tahun 2013 dan Rancangan Perda tentang RTRW Kota Depok tahun 2012-2032; This Study was conducted to review the regulations on minimum area requirements of each housing unit in Depok City.
