Tesis ini membahas tentang kelembagaan lokal Kelompok Tani Mawar dalam mengelola Sistem Integrasi Padi Ternak (SIPT), di Desa Lubuk Bayas Kecamatan Perbaungan Kabupaten Serdang Bedagai Provinsi Sumatera Utara.

Tujuan dari penelitian ini adalah menggambarkan pengelolaan program program SIPT berbasis kelembagaan lokal dan mengetahui faktor-faktor penguat keberadaan kelembagaan lokal Kelompok Tani Mawar. Penelitian ini menggunakan pendekatan kualitatif dengan jenis penelitian deskriptif. Pemilihan informan menggunakan teknik purposif sampling dan snowball sampling.
