Sebagai institusi yang disponsori oleh AS, TPP diproyeksikan sebagai high level FTA yang tidak sekedar mencakup kesepakatan terkait perdagangan dan investasi namun juga isu-isu lain yang lebih kompleks seperti perlindungan hak cipta (IPR), perlindungan hak buruh, kompetisi terkait Badan Usaha Milik Negara, dan beberapa isu-isu lain dengan standard yang cukup tinggi. Dengan persyaratan seperti ini, maka menjadi menarik ketika Vietnam memutuskan untuk bergabung ke dalamnya.
