## Abstrak

Notaris adalah suatu profesi yang mulia, karena peran dan tugasnya sebagai pejabat umum yang berwenang untuk membuat akta otentik. Fungsi dan peran notaris ialah memberikan pelayanan kepada masyarakat berupa penyuluhan hukum serta menjaga kepentingan pihak yang terkait dalam pelaksanaan jabatan Notaris harus didasarkan pada aturan dalam Kitab Undang-Undang hukum Perdata, Undang-Undang Jabatan Notaris dan juga menjunjung tinggi Kode Etik Notaris. Karena Notaris merupakan suatu jabatan maka ditentukan masa jabatan Notaris yang terdapat dalam pasal 8 Undang-Undang Jabatan Notaris. Setelah berakhirnya masa jabatan tersebut, seorang Werda Notaris tetap bertanggung jawab terhadap semua akta yang pernah dibuat pada saat menjabat. Majelis Pengawas Notaris adalah badan yang bentuk oleh Menteri Hukum dan Hak Asasi Manusia sebagai badan yang di tunjuk oleh Undang-Undang Jabatan Notaris dalam pengawasan terhadap Notaris. Pada dasarnya pengawasan yang dilakukan oleh Majelis Pengawas Notaris adalah terhadap Notaris yang masih aktif menjabat sebagai Notaris. Maka terdapat batasan dalam penindakan Majelis Pengawas Notaris terhadap Notaris yang masa jabatannya telah berakhir yakni dalam memberikan sanksi terhadap pelanggaran Kode Etik. Tesis ini menggunakan metode penelitian yuridis normatif dengan analisis data secara kualitatif. Dari hasil analisis dapat ditarik kesimpulan bahwa Majelis Pengawas Notaris tidak dapat memberikan sanksi terhadap pelanggaran yang dilakukan oleh Werda Notaris pada saat menjabat karena sudah tidak lagi menjabat sebagai Notaris.
