Abstrak

ABSTRAK

Praktek Kerja Profesi (PKP) yang dilaksanakan di Rumah Sakit Umum Pusat Fatmawati (RSUP Fatmawati) berlangsung selama dua bulan. Kegiatan ini bertujuan agar mahasiswa dapat memahami peranan, tugas, dan tanggung jawab Apoteker di Rumah Sakit sesuai dengan ketentuan, etika pelayanan farmasi khususnya, dan pelayanan kesehatan umumnya; memiliki wawasan, pengetahuan, keterampilan, dan pengalaman praktis untuk melakukan praktek kefarmasian di rumah sakit; dan memiliki gambaran nyata tentang permasalahan praktek kefarmasian, serta mempelajari strategi dan kegiatan-kegiatan yang dapat dilakukan dalam rangka pengembangan praktek kefarmasian di rumah sakit. Apoteker yang bertugas di RSUP Fatmawati telah melaksanakan tugas dan tanggung jawabnya dengan baik. Peranan, tugas, dan tanggung jawab Apoteker di Rumah Sakit adalah melakukan pengelolaan Obat dan Bahan Medis Habis Pakai, serta pelayanan farmasi klinik. Wawasan, pengetahuan, keterampilan, dan pengalaman yang didapat selama PKPA dirasa cukup untuk mahasiswa agar dapat melakukan praktek profesi kefarmasian. Permasalahan kefarmasian yang menyebabkan belum optimalnya pelayanan kefarmasian di Rumah Sakit adalah kurangnya Tenaga Kefarmasian, serta sarana dan prasarana yang kurang memadai. Strategi dan kegiatan yang telah dilakukan selama PKPA telah cukup dilakukan sebagai pembelajaran dalam rangka pengembangan praktek kefarmasian di Rumah Sakit.

ABSTRAK

Profession Internship was held in Rumah Sakit Umum Pusat Fatmawati (RSUP Fatmawati) for two months. This internship aims to make students understand the roles, duties, and the responsibilities of hospital pharmacists based on the provisions, particularly the ethics of pharmaceutical care, and health services in general; have the insights, knowledges, skills, and practical experience to practice the pharmaceutical in hospital; and have a real image about the problems of pharmaceutical practices, as well as learn the strategies and activities that established for the development of pharmaceutical practices at hospital. Pharmacists who served in RSUP Fatmawati were ended the duties and responsibilities well. The roles, duties, and responsibilities of pharmacists in hospital was managing Drugs and Consumable Medical Materials and clinical pharmacy services. The insights, knowledges, skills, and experiences which gained during PKPA was enough for students to make them able to practice the professions of pharmaceutical. Pharmaceutical issues which caused the nonoptimal pharmaceutical services in hospitals was the less pharmaceutical workers, and also inadequate of facilities and infrastructures. Strategies and activities during PKPA have been done as a learning for the development of pharmaceutical practice at hospital.;
