#### <b>ABSTRAK</b><br>

Apotek merupakan sarana pelayanan kefarmasian tempat dilakukan praktik kefarmasian oleh apoteker. Pelayanan kefarmasian adalah suatu pelayanan langsung dan bertanggungjawab kepada pasien yang berkaitan dengan sediaan farmasi dengan maksud mencapai hasil yang pasti untuk meningkatkan mutu kehidupan pasien. Praktek Kerja Profesi Apoteker PKPA di Apotek Kimia Farma No. 389 dilaksanakan pada Bulan Agustus 2016 dengan tujuan agar mahasiswa apoteker lebih memahami tugas, peran dan tanggung jawab apoteker di apotek yang berdasarkan pada standar pelayanan kefarmasian. #### <b>ABSTRACT</b><br>

Pharmacy is a pharmaceutical care facility where pharmaceutical practices are done by apothecary. Pharmaceutical care is a direct care and responsible to the patient associated with pharmaceutical dosage with the intention of reaching a definitive result to improve the quality of life of patients. Profession Internship at Kimia Farma Pharmacy Number 389 was held at August 2016. This internship was intended to make apothecary student understand the tasks, roles and responsibilities of pharmacist in pharmacy based on standards of pharmaceutical care. Managerial activities of pharmaceutical products, medical devices, and single use medical tools in Kimia Farma Pharmacy Number 389 are appropriated to Regulation of Minister of Health No. 35 Year 2014 about Standarization of Pharmaceutical Care in Pharmacy. Clinical pharmacy activities in Kimia Farma Pharmacy Number 389 that are not done are home pharmacy care, monitoring of drug therapy, and monitoring of drugs side effect.
