### Abstrak

Rumah Sakit sebagai salah satu fasilitas pelayanan kesehatan merupakan bagian dari sumber daya kesehatan yang sangat diperlukan dalam mendukung penyelenggaraan upaya kesehatan. Penyelenggaraan pelayanan kesehatan di Rumah Sakit mempunyai karakteristik dan organisasi yang sangat kompleks. Penyelenggaraan pelayanan kesehatan di Rumah Sakit perlu ditunjang dengan pelayanan kefarmasian yang bermutu. Pelayanan Kefarmasian di Rumah Sakit meliputi Pengelolaan Sediaan Farmasi, Alat Kesehatan, dan Bahan Medis Habis Pakai; serta Pelayanan Farmasi Klinik. Pengelolaan Sediaan Farmasi, Alat Kesehatan, dan Bahan Medis Habis Pakai terdiri dari pemilihan, perencanaan kebutuhan, pengadaan, penerimaan, penyimpanan, pendistribusian, pemusnahan dan penarikan, pengendalian, administrasi. Pelayanan Farmasi Klinik terdiri dari pengkajian dan pelayanan resep, penelusuran riwayat penggunaan obat, rekonsiliasi obat, pelayanan informasi obat, konseling, visite, monitoring efek samping obat, evaluasi penggunaan obat, dispensing sediaan steril, pemantauan kadar obat dalam darah. Pelayanan kefarmasian di Rumah Sakit Umum Pusat Fatmawati sudah berjalan secara optimal, namun pelayanan farmasi klinik berupa pemantauan kadar obat dalam darah PKOD belum dilakukan.

Hospital as one of the health service facilities is part of health resources that are needed in supporting the implementation of health efforts. The provision of health services in hospitals has very complex characteristics and organization. Implementation of health services in hospitals should be supported by quality pharmaceutical services. Implementation of health services in hospitals should be supported by quality of pharmaceutical services. Pharmaceutical Care at the hospital include the Management of Pharmaceutical Products, Medical Devices, Medical Materials and Consumables and clinical pharmacy services. Management of Pharmaceutical Products, Medical Devices, Medical Materials and Consumables consist of the selection, requirement planning , procurement, receipt, storage, distribution, destruction and withdrawal, control, administration. Clinical pharmacy services consist of assessment and prescription services, history of drug use, drug reconciliation, drug information services, counseling, visit, monitoring of drug side effects, drug use evaluation, sterile dose dispensing, monitoring blood drug levels. Pharmaceutical care at RSUP Fatmawati have been running optimally, but clinical pharmacy service in the form of monitoring blood drug levels PKOD has not been done.
