ABSTRAK

Apotek merupakan sarana pelayanan kefarmasian tempat dilakukan praktik kefarmasian oleh Apoteker. Pelayanan kefarmasian di Apotek harus sesuai dengan standar yang telah ditetapkan meliputi pengelolaan sediaan farmasi, alat kesehatan, dan bahan medis habis pakai dan pelayanan farmasi klinik. Kegiatan pelayanan kefarmasian di Apotek merupakan tanggung jawab Apoteker sesuai dengan peraturan perundang-undangan yang berlaku. Praktek Kerja Profesi Apoteker PKPA dilaksanakan di Apotek Kimia Farma No. 7 Bogor pada tanggal 1 Februari hingga 28 Februari 2017. Pelaksanaan PKPA bertujuan untuk memahami tugas dan tanggung jawab Apoteker Pengelola Apotek dalam hal teknis kefarmasian maupun non teknis kefarmasian, memiliki pengetahuan dan pengalaman praktis untuk melakukan praktik pelayanan kefarmasian di Apotek, dan memiliki gambaran nyata tentang permasalahan praktik kefarmasian di Apotek serta mempelajari strategi penyelesaiannya. Kegiatan yang dilakukan selama PKPA di Apotek Kimia Farma No. 7 Bogor antara lain pelayanan resep, analisis resep, dispensing sediaan farmasi, dan mempelajari pengelolaan sediaan farmasi di Apotek.

Pharmacy is a pharmaceutical care facility where the pharmaceutical practice is performed by a pharmacist. Pharmaceutical care in Pharmacy must comply with the defined standard including management of pharmaceutical products, medical devices, and medical consumables as well as clinical pharmaceutical care. Pharmaceutical care activities in Pharmacy are the responsibility of pharmacist in accordance with the applicable laws and regulations. Internship at Kimia Farma Pharmacy number 7 Bogor was held on February 1st to February 28th, 2017. This internship aims to understand the duties and responsibilities of pharmacist in terms of technical and non technical pharmaceutical activities in Pharmacy, obtain the knowledge and practical experiences to perform pharmaceutical practice in Pharmacy, and obtain a real description of pharmaceutical practice issues in Pharmacy as well as studying its solution.
