Praktik Kerja Profesi Apoteker di RSUP Fatmawati Periode Bulan Juli-Agustus Tahun 2017 dilaksanakan selama 6 minggu yang bertujuan untuk memahami peranan, tugas, dan tanggung jawab apoteker di rumah sakit sesuai dengan standar pelayanan farmasi di rumah sakit, memiliki wawasan, pengetahuan, keterampilan, dan pengalaman praktis untuk melakukan praktek kefarmasian di rumah sakit, serta memiliki gambaran nyata tentang permasalahan praktik kefarmasian di rumah sakit serta mempelajari strategi dan kegiatan-kegiatan yang dapat dilakukan dalam rangka pengembangan praktek kefarmasian di rumah sakit. Tugas khusus yang diberikan yaitu berjudul Pemantauan terapi obat pada pasien bayi cukup bulan dengan pneumonia di ruang nicu-hcu gedung bougenville. Tujuan tugas khusus ini adalah untuk memantau terapi obat pada pasien yang terdapat di ruangan NICU-HCU, mengidentifikasi permasalahan terkait obat dan mengetahui rekomendasi yang tepat untuk mencapai keberhasilan terapi yang diterima pasien. Internship at Fatmawati General Hospital July-August 2017 are conducted for 6 weeks which aimed to understanding the role, duties and responsibilities of pharmacists in hospitals in accordance with the pharmaceutical service standards in hospitals, having insight, knowledge, skills and practical experience in conducting pharmaceutical practice in the hospital, as well as having a real experiences of the problems of pharmaceutical practice in the hospital as well as studying the strategies and activities that can be done in order to develop the pharmaceutical practice in the hospital. The special assignment given is titled Monitoring of drug therapy in term infant patients with pneumonia in the nicu-hcu room of the bougenville building. The purpose of this special assignment are monitoring drug therapy in patients in the NICU-HCU room, identifying drug-related issues and knowing the right recommendations for achieving the patient's treatment success.
