## Abstrak

### **<b>ABSTRAK</b>**

Apotek merupakan sarana pelayanan kefarmasian tempat dilakukan praktik kefarmasian oleh Apoteker. Praktik Kerja Profesi PKP di Apotek Kimia Farma No 152 dilakukan pada tanggal 4 April – 30 April 2018. PKP dilaksanakan dengan tujuan untuk memperoleh pengalaman kerja, pengetahuan, gambaran, dan pemahaman yang lebih mendalam tentang peran, tugas, dan tanggung jawab Apoteker dalam pengelolaan sediaan farmasi dan melaksanakan pelayanan farmasi klinik di Apotek. Kegiatan yang dilakukan selama PKP yaitu mempelajari dan melaksanakan kegiatan pekerjaan kefarmasian, baik dalam pengelolaan sediaan farmasi dan bahan medis habis pakai, maupun kegiatan pelayanan farmasi klinik. Kegiatan pengelolaan sediaan farmasi yang dilakukan antara lain perencanaan, pengadaan, penerimaan, penyimpanan, pengendalian, serta pencatatan dan pelaporan. Di sisi lain, kegiatan pelayanan farmasi klinik yang dilakukan antara lain pelayanan obat resep, seperti pengkajian resep, peracikan, penyerahan obat, dan pemberian informasi obat; pelayanan obat nonresep; pelayanan informasi obat PIO ; dan konseling. Pelaksanaan pekerjaan kefarmasian di Apotek Kimia Farma No 152 Pasar Minggu sudah cukup baik berdasarkan PMK 73 Tahun 2016, namun terdapat beberapa kegiatan belum dilakukan seperti pemantauan terapi obat PTO , monitoring efek samping obat MESO , serta dokumentasi kegiatan PIO dan Konseling.

Pharmacy is a pharmaceutical care facility where pharmaceutical practice is undertaken by a pharmacist. Internship at Kimia Farma 152 Pharmacy was held on April 4th - April 30th, 2018. Internship was implemented in order to obtain a working experience, knowledge, overview, and understanding the role, duties and responsibilities of Pharmacists in management pharmaceutical product and carry out clinical pharmacy services. Activities undertaken during the internship were to study and carry out pharmaceutical work activities, both in the management of pharmaceutical product, as well as clinical pharmaceutical care. Pharmaceutical product activities were carried out include planning, procurement, receipt, storage, control, and recording and reporting. On the other hand, clinical pharmaceutical care activities included prescription drug services, such as prescription assessment, compounding, dispensing, and provision of drug information; non-prescription drug services; drug information services PIO ; and counseling. Pharmaceutical care at Kimia Farma 152 Pasar Minggu Pharmacy was quite good based on PMK 73 of 2016, but there were some activities that have not been done such as monitoring of drug therapy, monitoring of drug side effects, and documentation of PIO and Counseling activities.
