### Abstrak

Praktik Kerja Profesi Apoteker di PT Guardian Pharmatama Citeureup Periode Bulan Maret ndash; April Tahun 2018 bertujuan untuk memahami peran, tugas dan tanggung jawab Apoteker di Industri Farmasi serta mempelajari penerapan Cara Pembuatan Obat yang Baik CPOB di Industri Farmasi. Calon Apoteker juga memperoleh gambaran nyata tentang permasalahan pekerjaan kefarmasian di Industri Farmasi, memiliki wawasan, pengetahuan, keterampilan dan pengalaman praktis dalam melakukan pekerjaan kefarmasian di Industri Farmasi. Tugas khusus yang diberikan berjudul Idquo;Dokumentasi Cara Pengoperasian Mesin Vakumix Tipe VHM 100 dan ABF 80 untuk On Job Training Operator Departemen Produksi Liquid Semisolid dan Toll Out Toll In rdquo;.
