## Abstrak

Praktik kerja profesi apoteker dilakukan dengan tujuan untuk memahami praktik kefarmasian di sarana kesehatan. Praktik kerja kefarmasian dilaksanakan di Apotek Kimia Farma No. 362 Cibinong selama bulan April 2018. Praktik kerja di apotek dimaksudkan agar mahasiswa dapat memahami secara langsung peran apoteker dalam melaksanakan pekerjaan kefarmasian di apotek baik dalam melakukan pengelolaan sediaan farmasi, alat kesehatan, dan bahan medis habis pakai serta pelayanan farmasi klinik sesuai dengan standar pelayanan kefarmasian di apotek. Kegiatan selama praktik kerja di apotek salah satunya adalah melaksanakan tugas khusus yaitu "Pengkajian Resep Penyakit Diabetes Melitus di Apotek Kimia Farma No. 362". Pengakjian resep dilakukan sesuai dengan standar pelayanan kefarmasiaan yaitu dengan menilai kesesuaian administrasi, kesesuaian farmasetik, dan kesesuaian klinis terhadap resep yang ditujukan untuk penyakit Diabetes Melitus di Apotek. Hasil pengkajian resep yang dilakukan akan menentukan tindak lanjut apa yang akan diberikan kepada pasien jika hasil pengkajian ditemukan masih tidak sesuai.

The pharmacy practice was carried out at Kimia Farma Pharmacy No. 362 Cibinong during April 2018. Intern in pharmacies are intended to enable students to understand directly the role of pharmacists in carrying out pharmaceutical practice in pharmacies both in managing pharmaceutical preparations, medical devices, and medical consumables and clinical pharmacy in accordance with standard of pharmaceutical services at the pharmacy. Activities during the work practice in pharmacies one of them is to carry out a special task that is Assessment of Diabetes Mellitus Prescription Recipe in Kimia Farma Pharmacy No. 362. The prescribing assessment is performed in accordance with the standard of pharmaceutical services by assessing the suitability of administration, pharmaceutical suitability, and clinical appropriateness of prescriptions intended for Diabetes Mellitus at Pharmacies. The results of the prescribed assessment will determine what follow-up will be given to the patient if the results of the findings are found to be incompatible.</i>
