

## Praktik kerja profesi di PT. Anugerah Pharmindo Lestari Branch Bogor Periode Oktober 2018 = Internship at PT. Anugerah Pharmindo Lestari Bogor Branch Period of October 2018

### Abstrak

Praktik kerja profesi di PT. Anugerah Pharmindo Lestari cabang Bogor periode bulan Oktober tahun 2018 bertujuan agar calon Apoteker dapat memahami peranan, tugas, dan tanggung jawab Apoteker di PBF dan PAK, memiliki wawasan, pengetahuan, keterampilan, dan pengalaman praktis untuk melakukan pekerjaan kefarmasian di PBF dan PAK, memahami penerapan CDOB di PBF dan CDAKB di PAK, serta memiliki gambaran nyata tentang permasalahan pekerjaan kefarmasian di PBF dan PAK. Selama praktik kerja profesi penulis mempelajari alur proses distribusi produk pharma dan produk alkes di kantor cabang, dokumen-dokumen yang diperlukan, pelaporan, penanganan keluhan, retur, recall, proses perizinan, persyaratan kondisi ruangan gudang, dan validasi pengiriman. “Validasi Metode Pengiriman Cold Chain Product Menggunakan Styrofoam di PT. Anugerah Pharmindo Lestari Branch Bogor” merupakan tugas khusus penulis dimana penulis melakukan validasi pengiriman produk *dummy* ke Cianjur menggunakan kemasan pasif Styrofoam. Validasi dilakukan sebanyak tiga kali pengiriman. Hasil menunjukkan bahwa Styrofoam GG dapat mempertahankan suhu pada rentang 2 °C – 8 °C namun tidak dalam periode waktu yang lama karena mudah terjadi ekskursi suhu apabila pengemasan dan handling kurang tepat. Suhu lingkungan memberikan dampak yang besar terhadap kestabilan suhu pengiriman produk rantai dingin di dalam Styrofoam GG. Secara umum, PT. Anugerah Pharmindo Lestari cabang Bogor telah memenuhi ketentuan yang tercantum dalam CDOB dan CDAKB.

Internship at PT. Anugerah Pharmindo Lestari Bogor branch period of October 2018 was aimed to understand roles, duties, and responsibilities of Pharmacist in Pharmaceutical and Medical Devices Wholesaler, to have knowledge, skills, and practical experience to do pharmaceutical affairs, to understand application of Good Distribution Practices (GDP) in wholesaler, and also to have insight about problems that will be faced by pharmacist in wholesale field. During the internship, author learned about distribution flow process of pharma product and medical devices product, documentation, report, complaint handling, returned goods handling, product recall, licensing process, and warehouse condition requirements according to GDP, and shipping validation. “Shipping Validation of Cold Chain Product Using Styrofoam Packaging at PT. Anugerah Pharmindo Lestari Bogor Branch” was author’s special assignment where shipping validation of dummy product to Cianjur using passive packaging Styrofoam type GG was performed. Validation was done by three times of shipping. Result showed that Styrofoam GG can maintain temperature in range 2 °C – 8 °C but not in a long period of time because temperature excursion was easily happen when packaging procedure and handling was not properly done. Environment temperature gave substantial impact towards stability of shipping temperature of cold chain product inside Styrofoam GG. Principally, activities in PT. Anugerah Pharmindo Lestari Bogor Branch was conformed to the requirements and regulations in Good Distribution Practices
