## Abstrak

Praktek Kerja Profesi Apoteker dilaksanakan di Rumah Sakit Umum Pusat Nasional Dr. Cipto Mangunkusumo Jl. Pangeran Diponegoro Nomor 71, Jakarta Pusat dari tanggal 2 Agustus hingga 28 September 2018. Kegiatan PKPA bertujuan agar mahasiswa memahami tugas dan tanggung jawab apoteker di rumah sakit melakukan praktek pelayanan kefarmasian sesuai dengan ketentuan yang berlaku, dan meningkatkan pengetahuan, keterampilan, serta pengalaman praktis untuk melakukan praktek kefarmasian di Rumah Sakit. Kegiatan yang dilakukan selama PKPA yaitu: Pengelolaan sediaan farmasi, alat kesehatan dan bahan medis habis pakai (BMHP) meliputi pemilihan, perencanaan kebutuhan, pengadaan, penerimaan, penyimpanan, pendistribusian, pengendalian, pemusnahan dan penarikan, serta administrasi; dan dalam kegiatan pelayanan farmasi klinik yang meliputi pengkajian dan pelayanan resep, riwayat penggunaan obat, rekonsiliasi obat, pelayanan informasi obat (PIO), konseling, visit, pemantauan terapi obat (PTO), evaluasi penggunaan obat (EPO), dan monitoring efek samping obat (MESO). Selain itu, memahami peran dan tugas di unit produksi dan aseptik dispensing dan Instalasi sterilisasi Pusat. Tugas khusus yang diberikan berjudul pemantauan terapi obat pada pasien anak pneumonia nosokomial di RSUPN Dr. Cipto Mangunkusumo. Tujuan dari tugas khusus agar mahasiswa mampu memahami tugas dan tanggung jawab apoteker dalam praktek pemantauan terapi obat (PTO), mengetahui kerasionalan terapi pada pasien pneumonia nosokomial selama perawatan, dan menganalisis masalah terkait obat yang terjadi pada pasien selama dirawat di ruang rawat inap Gedung A RSUPN Dr. Cipto Mangunkusumo.

Pharmacist internship working program at the National Center General Hospital Dr. Cipto Mangunkusumo on Pangeran Diponegoro Street Number 71, Central Jakarta from August 2 to September 28 2018. The purpose of internship working program aims to understand the duties and responsibilities of pharmacist in hospitals to practice pharmacy services in accordance with applicable regulations, and improve knowledge, skills, and practical experience to practice pharmacy at the Hospital. Activities carried out during pharmacist internship are Management of pharmaceutical preparations, medical devices and consumable medical materials covering the selection, planning of needs, procurement, receipt, storage, distribution, control, extermination, and administration; and in clinical pharmacy service activities which include assessment and prescription services, medical history taking, drug reconciliation, drug information services, counseling, visite, therapeutic drug monitoring, evaluation of drug use, and monitoring of drug side effects. In addition, understanding the roles and tasks in the production and aseptic dispensing units and the Central Sterilization Installation. Special assignment given was entitled monitoring drug therapy in pediatric nosocomial pneumonia patients at Dr. RSUPN. Cipto Mangunkusumo. The purpose of this special assignment is that students are able to understand the duties and responsibilities of pharmacists in the practice of therapeutic drug monitoring, know the therapeutic rationality of nosocomial pneumonia patients during treatment, and

analyze drug-related problems that occur in patients while being treated in the inpatient building Building A RSUPN Dr. Cipto Mangunkusumo.
