Abstrak

Laporan magang ini membahas mengenai evaluasi proses penilaian tata kelola perusahaan yang dilakukan pada PT Euphoria berdasarkan standar Australian Securities Exchange Corporate Governance Council (ASX CGC) Principles 4 th Edition dan refleksi diri dari kegiatan magang yang dilakukan di KAP Vante. PT Euphoria merupakan perusahaan yang terdaftar dalam Australian Securities Exchange (ASX) Listing sehingga diwajibkan untuk melakukan pengungkapan praktik tata kelola perusahaan berdasarkan ketentuan dari ASX dalam laporan tahunan. Proses penilaian tata kelola perusahaan PT Euphoria dievaluasi dengan menggunakan ASX Listing Rule 4.10.3 dan ASX CGC Principles 4th Edition. Refleksi diri yang di bahas dalam laporan ini di dasarkan pada

pengalaman aktivitas magang yang diperoleh selama kegiatan magang. Berdasarkan hasil evaluasi diketahui bahwa proses penilaian yang dilakukan oleh KAP Vante pada PT Euphoria telah sesuai dengan standar yang berlaku. Kemudian, berdasarkan hasil refleksi diri dapat ditarik kesimpulan bahwa kegiatan magang yang dilaksanakan di KAP Vante membantu dalam meningkatkan soft skill dan hard skill.

.....This report discusses the evaluation of the corporate governance assessment process conducted at PT Euphoria based on the Australian Securities Exchange Corporate Governance Council (ASX CGC) Principles 4th Edition and self-reflection of the apprenticeship activities carried out at Vante`s Public Accountant Firm. PT Euphoria is a company registered on the Australian Securities Exchange (ASX) Listing, so it is required to disclose corporate governance practices based on the provisions of ASX in the annual report. The process of evaluating PT Euphoria`s corporate governance was evaluated using ASX Listing Rule 4.10.3 and ASX CGC Principles 4th Edition. The self-reflection discussed in this report is based on the experience of the apprenticeship activities obtained during the apprenticeship activities. Based on the evaluation results it is known that the appraisal process carried out by KAP Vante at PT Euphoria complies with applicable standards. Then, based on the results of self-reflection, it can be concluded that the apprenticeship activities carried out at Vante`s Public Accountant Firm help in increasing soft skills and hard skills.
