

# **Praktik Kawin Kontrak Di Desa Tugu Puncak Bogor Pada Masa Pandemi COVID-19 = The Practical Of Contract Marriages In Tugu Village, Puncak, Bogor During COVID-19 Pandemic**

## **Abstrak**

Sejak pandemi COVID-19, tidak ada kedatangan turis Arab di Puncak, Bogor. Kondisi ini berdampak terhadap penurunan perekonomian, terutama di Desa Tugu. Penelitian ini membahas tentang praktik kawin kontrak di Desa Tugu. Masalah yang akan dibahas pada penelitian ini adalah bagaimana persepsi masyarakat dan UUD terhadap kawin kontrak, bagaimana eksistensi kawin kontrak saat pandemi COVID-19 dan bagaimana dampak yang ditimbulkan dari ketiadaan kawin kontrak di Desa Tugu saat pandemi COVID-19. Penulisan ini menggunakan metode kualitatif dengan teknik pengumpulan data yaitu wawancara dan observasi. Teori yang digunakan penelitian adalah teori kawin kontrak menurut Al-Ghazali, teori perilaku menyimpang milik Robert M.Z, dan teori persepsi dari Thoha. Penelitian ini memperoleh hasil yaitu praktik kawin kontrak termasuk sebagai salah satu perilaku penyimpangan karena melanggar norma sosial, hukum, dan agama. Selama pandemi, praktik kawin kontrak sudah tidak pernah terjadi lagi karena tidak ada kedatangan turis Arab ke Puncak, Bogor. Ketiadaan kawin kontrak bukan hanya memberikan dampak penurunan ekonomi kepada wanita pelaku, tetapi berdampak juga pada beberapa sektor yang ada di kawasan Desa Tugu, seperti travel, tukang ojek, penyewaan villa, dan pedagang sekitar. ....Since the COVID-19 pandemic, there have been no Arab tourist arrivals in Puncak, Bogor, which has an impact on the poor economy, especially in Tugu Village. This study discusses the practice of contract marriage in Indonesia Tugu Village, Puncak, Bogor. The problem that will be discussed in this research is about how the existence of contract marriages during the COVID-19 pandemic and what are the impacts of not getting married contract in Tugu Village during the COVID-19 pandemic. This study uses a qualitative approach and descriptive-amalitis method with data collection techniques, namely interviews and observations. Theory used on this research is the contract marriage theory according to Al-Ghazali, Robert M. Z's theory of deviant behavior, the theory of perception and Thoha. This study obtained the results that the practice of contract marriage is included as one of the social deviation because it violates social, legal, and religious. During the pandemic, the practice of mating the contract has never happened again because there are no single Arab tourists coming to Puncak, Bogor. The absence of contract marriages not only have an impact on the economic decline for female perpetrators, but also have an impact in several sectors in the Tugu Village area, such as travel, motorcycle taxi drivers, villa rentals, and so on social workers around.
