## Abstrak

Praktek Perkawinan anak di Pakistan merupakan pelanggaran norma sosial yang telah terjadi di masyarakat Pakistan sebelum Pakistan mendapat kemerdekaannya dari India. Untuk mengatasi permasalahan tersebut, pemerintah Pakistan telah memberlakukan UU tentang larangan perkawinan anak. Namun, perkawinan anak masih marak terjadi dalam masyarakat Pakistan. Penelitian ini bertujuan untuk menganalisa serta mengkaji peran

Dalam menganalisis peran Save the Children dalam penurunan perkawinan anak di Pakistan penulis menggunakan konsep Peran International Non-Governmental Organization (INGO) Menurut David Lewis dan Nazneen Kanzi. Studi ini menggunakan metode penelitian kualitatif dan dikembangkan dengan menggunakan teknik kepustakaan. Sumber data yang digunakan dalam penelitian ini diperoleh melalui beberapa cara. .....The practice of child marriage in Pakistan is a violation of social norms that has occurred in Pakistani society before Pakistan got its independence from India. To overcome these problems, the government of Pakistan has enacted a law on the prohibition of child marriage. However, child marriage is still rife in Pakistani society. This study aims to analyze and examine the role of Save the Children in reducing child marriage in Pakistan (2019-2021). In analyzing the role of Save the Children in reducing child marriage in Pakistan, the authors use the concept of the Role of International Non-Governmental Organizations (INGOs) according to David Lewis and Nazneen Kanzi. This study uses qualitative research methods and is developed using library techniques. Sources of data used in this study were obtained in several ways. Primary data sources are obtained from sources in the form of official documents or publications, both obtained from related parties and the official website of Save the Children. Meanwhile, secondary data sources are obtained by conducting literature reviews of various scientific sources such as journals or books as well as credible sources from the internet.
