Abstrak

Penelitian ini bertujuan untuk menggambarkan collaborative governance yang dilaksanakan oleh Gugus Tugas Percepatan Penanganan Covid 19 (GTPPC-19) tingkat kelurahan dalam penanganan pandemi Covid 19 di Kelurahan Lubang Buaya, Kecamatan Cipayung, Kota Administrasi Jakarta Timur. Penelitian ini secara khusus mengamati Gugus Tugas Percepatan Penanganan Covid 19 (GTPPC-19) Kelurahan Lubang Buaya dalam menangani permasalahan pandemi Covid 19 di wilayahnya. Teori yang digunakan adalah teori collaborative governance. Pendekatan penelitian yang digunakan adalah post-positivist dengan teknik pengumpulan data wawancara mendalam dan studi dokumen. Hasil penelitian ini menunjukkan bahwa pihak kelurahan dan gugus tugas yang dibentuk dalam menghadapi pandemi COVID-19 mengalami sejumlah tantangan terutama dalam meningkatkan kesadaran masyarakat. Kondisi ini mendorong pula upaya Pemerintah Kelurahan Lubang Buaya untuk menggandeng sejumlah pihak seperti Puskesmas Lubang Buaya, Kepolisian Sektor Cipayung, Koramil, Lubang Buaya, Satpol PP Kelurahan, tokoh masyarakat dan tokoh agama. Penelitian ini menemukan sejumlah kelebihan dan kelemahan dalam pelaksanaan kolaborasi penanganan pandemi Covid-19 di level kelurahan.

.....This research aims to describe collaborative governance which is conducted by sub-district level of the Task Force for the Acceleration of Covid 19 Handling (GTPPC-19) in handling the Covid 19 pandemic in Lubang Buaya sub-district, Cipayung District, East Jakarta Administrative City. This research specifically observes the Task Force for the Acceleration of Handling Covid 19 (GTPPC-19) Lubang Buaya sub-district to handling the Covid 19 pandemic problem in its region. The theory used is the theory of collaborative governance. The research approach used was post-positivist with in-depth interviews and document study data collection techniques. This study found that the sub district or village level in addressing COVID-19 pandemic face several challenges in particularly in increasing ciizen awareness. This condition motivates the government to collaborate with other actors such as police, health faciliies, military, education sector, public figure, religious leaders, and public. This research found a number of advantages and weaknesses in the implementation of collaboration in handling the COVID-19 pandemic at the village level.
