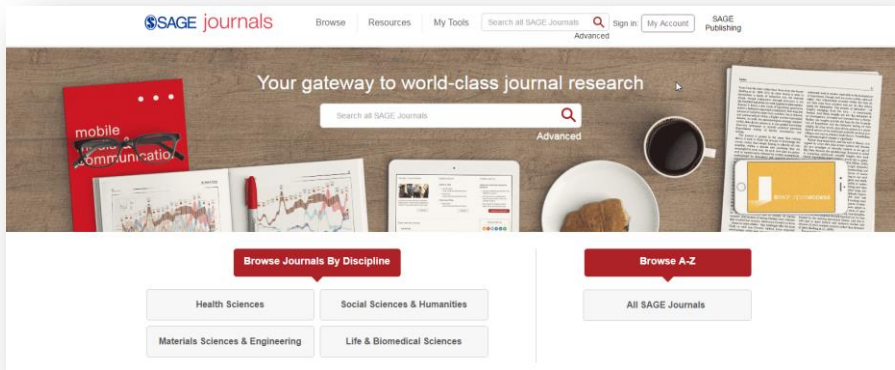

### Search

Search across all full-text articles by entering keywords or author information in the "Search all SAGE Journals" box on the main site navigation page. Search within an individual journal by using the "Search this Journal" box on the journal page.

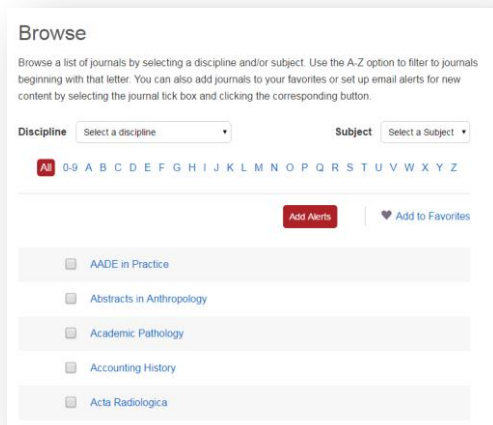
## Advanced Search

The Advanced Search tool uses a signature fielded Boolean system. This allows you to construct a multi-term query specifying terms and their logical relationships using the Boolean operators "and," "or," and "not." Multiple terms entered in a single search box are treated as an exact phrase. Additional rows can be used to enter search terms and limit a search across specified content areas (e.g., title, abstract, full text, references).

## Browse

### *Browsing Journals by Title*

Browse alphabetical journal lists by clicking a letter from the A-to-Z menu to jump to the corresponding list of journals. Navigate between results pages via the page numbers at the foot of the page.



### *Browsing Journals by Discipline*

Browse journals by discipline (Health Sciences, Life & Biomedical Sciences, Materials Science & Engineering, and Social Science & Humanities) and corresponding subjects.

Click the journal title to go to the homepage, where you can view journal information, OnlineFirst articles, and tables of contents, as well as conduct journal-level searches.

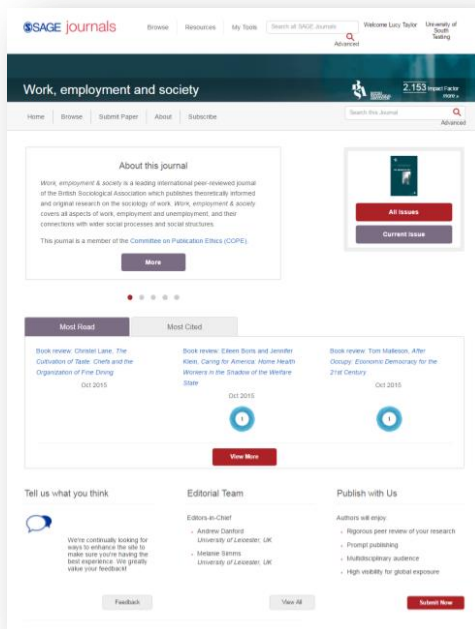
### *Add Alerts and Add to Favorites*

From either "Browse" option, when you have found a journal you are interested in, use the "Add to Favorites" and "Add Alerts" buttons to customize your **SAGE Journals** experience (users must be logged in to their personal account to use these tools).

## Journal Homepage

### Features include the following:

- **Follow-me journal menu:** The journal menu follows you as you scroll so that you always have access to quick links to the homepage; the current issue, OnlineFirst articles, and all issues; submission guidelines; and information about the journal, including links to editorial board listings, free sample issues, email alerts, and RSS feeds.
- **Impact factor and journal indexing:** Click the impact factor link to learn more about the journal's impact factor and ranking information.
- **Links to society sites:** These links provide information about our society and association partners.
- **Search this journal:** This feature allows you to run a keyword search across the journal's content.
- **Information carousel:** This carousel provides information and news about the journal.
- **Current issue:** This allows you to quickly navigate to the latest issue's table of contents.
- **All issues:** Here you can browse all issues by year or volume and issue number.
- **Most read and most cited articles:** This shows the six most read or cited articles from the last 7 days.
- **Submit paper:** Here you can find out how to submit your manuscript to the journal.
  - **OnlineFirst:** Articles that are published ahead of print (available for most journals).



- Connect with us: Share the journal through popular social media platforms.
- Email alerts: Sign up for new content alerts and announcements for the journal.
- Podcasts and videos: Find highlighted multimedia content, where available.
- Collections: View article collections handpicked by a journal's editor, where available.
- Related journals: This provides a link to society sister publications and other related SAGE publications.

- "Show Abstract" preview: Clicking "Show Abstract" expands an abstract preview to review, without leaving the page.
- Contents: Use the contents menu to navigate to different sections within the issue.

Time reclaimed: temporality and the experience of meaningful work

Abstract

The importance of meaningful work has been identified in scholarly writings across a range of disciplines. However, empirical studies remain sparse and the potential relevance of the concept of temporality, hitherto somewhat neglected even in wider sociological studies of organizations, has not been considered in terms of the light that it can shed on the experience of work as meaningful. These two disparate bodies of thought are brought together to generate new accounts of work meaningfulness through the lens of temporality. Findings from a qualitative study of workers in three occupations with ostensibly distinct temporal landscapes are reported. All jobs had the potential to be both meaningful and meaningless; meaningfulness arose episodically through work experiences that were shared, autonomous and temporally complex. Schutz's notion of the 'vivid present' emerged as relevant to understanding how work is rendered meaningful within an individual's personal and social system of relevances.

## More Helpful Features

### ***Getting Started***

Go to the **SAGE Journals** homepage at <http://journals.sagepub.com> and select the "My Account" button next to the sign-in prompt to log in or create your free personal account. You may also create your account from the "My Tools" tab. The registration process allows you to sign up for new content alerts, create a list of "My Favorite Journals," and save searches to receive alerts when new content is published matching your search terms via "My Saved Searches."

Note: Individuals with personal accounts who have not yet visited the new **SAGE Journals** platform (which launched in December 2016) will need to reset their password at <http://journals.sagepub.com/action/requestResetPassword> and use the email address associated with their account as their new username.

### ***Search History***

During your current session, you can rerun previous searches with the "Search History" feature. To access your search history, click "Refine Search" on the search results page and navigate to "Search History." For each search term you enter, you may run, edit, or add to "Saved Searches" (see "My Tools"), or save the term as an alert.

### ***My Account***

The "My Account" page allows you to
